NOTICE OF PUBLIC HEARINGS

Pursuant to Elections Code section 10010(a), before a political subdivision that is changing from an at-large method of election to a by-trustee area method of election draws a draft map or maps of the proposed boundaries of the trustee areas, the political subdivision shall hold at least two public hearings at which the public is invited to provide input regarding the composition of the trustee areas.

Topic of Public Hearings:

The transition to a by-trustee area election system and the composition of potential trustee voting areas in advance of the preparation of draft trustee voting area plans by the City's demographer.

Virtual Attendance Only and Remote Viewing Options:

The City Council for the City of Greenfield will be holding its first pre-map public hearing on Monday, January 31, 2022, and will be holding its second pre-map public hearing on Thursday, February 3, 2022. Consistent with Assembly Bill (AB) 361, the City Council will hold these meetings virtually only, without in-person attendance by the public and without a physical location for public participation. Further, and consistent with AB 361, the meetings are accessible for public participation through video conferencing and livestreaming.
