Tom Virsik stated that when developing a fee, it must meet certain standards and the one approved by the SVBGSA may or may not be the appropriate fees.

He stated that they have had good discussion with the Advisory Committee but it has been a good start. He stated that it should go back to the Advisory Committee again in October or November.

General Manager Weeks stated that there was a coordination meeting this month and they discussed the Arroyo Seco River Water Shed Protection Policy; implementation of the well permitting process, sub-committee for the Advisory Committee and the annual report.

Thomas Virsik stated that at the Coordination meeting Ms. Meyers, SVBGSA, spoke regarding having DWR review staff come to her Board and have them explain how the annual reports were being used; however, did not when the meeting would occur. He stated that it may or may not affect the Arroyo Seco GSA but wanted that Board to be aware of it.
